3. Upload the saved Release to the Voices Matter Entry Form.
4. Submit the entry form on or before on or before 11:59 p.m. on Friday, November 30, 2018.
5. Alternatively, please sign, complete, and mail the Release to UDCPC Audio Essay Contest, 111 Academy St., Room 190A, Newark, DE 19716. Mailed releases must be postmarked by November 30, 2018.

My audio essay (the "Work") may be presented at public events, aired on Delaware Public Media and WVUD Radio, published on a public Internet website, and shared on social media. This authorization assures that those involved know that the Work may be shown publicly without requiring further consent.
